MOTORCYCLE BOOTS OR JUST BOOTS



Hoping you are all well as we prepare for the holiday season. I would like to start by

introducing myself. My name is Frank Diaz and I have been a member of the Blue

Knights LEMC since 2015. I became Vice President of New York II in 2022 and

President since mid 2024. I have always been a big advocate for the recruitment of new members, retention of our senior members and more than that the camaraderie that put this organization on the map. I would also like to thank the Tri-State board for the honor of being your Tri-State Safety Officer. I will do my absolute best to pass on articles that may be news to some but serve as a reminder to others.

Back in 2020 I was involved in a motorcycle accident and my left ankle got the brunt of the damage. I'll spare you all the gory details, but I have since spent a lot of time researching footwear - both to protect my ankle but also to prevent any other damage should, God forbid, another incident occur. To quote a popular saying "Don't dress for the ride, dress for the slide."

I know I am preaching to the choir when I say, we do NOT wear sneakers, boat shoes, or dress shoes. For the ladies, no wedges or heels. And we damn sure do not wear flip flops, slides or sandals. We all know the damage wearing any of those can cause, both short and long-term injuries consisting of breaks, severe abrasions, and burns. Why should we wear purpose-built motorcycle boots? There are many reasons. The main one for me is safety. Motorcycle boots should be abrasion and heat resistant and more rigid than regular wear boots. Not to the point that it is to stiff to walk, but more rigid than our common work or western style boots. They should also cover and provide protection for your foot. Some have a toe box (different from a steel toe) that protects the toes from, lets just call it road rash, and also provides heel and ankle protection. The heel or ankle box provides protection from crushing. These protections you wouldn't find in your construction style work boots or fashion boots. Now I'm going to guess you're thinking, "But Frank, I like my work boots or my cowboy style boots". I'm happy to tell you, the middle ground is out there. Companies are making boots that look like our favorite boots but offer the protection of motorcycle boots. Another misconception is that tactical or military boots provide adequate protection. While, they do come from a longesteemed tradition of battle and street tested quality, these boots won't protect your foot and ankle in case of a 'slide'. Some of us may have even worn these on the streets or in combat, which may make them seem like a practical choice, but not for motorcycle safety.

Another good reason for purpose-built boots is longevity. Oils and heat coming off your engine can degrade regular leather boots. Motorcycle boots would be able to withstand this. Also realizing that if we don't heel shift, most of our shifting is done with our left foot. Purpose-built boots can have a reinforced toe area to keep this particular area from wearing out over time.

In closing, when choosing a pair of purpose-built motorcycle boots there are a few things to take into consideration - safety, comfort and yes, looks are important. Also understanding a good, quality pair of boots can be an expensive investment, I think we would all agree - as a helmet is to our head, our feet are worth it.
